For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Guest grants CNN, and any of its licensees, designees and assigns (collectively, the "Released Parties") the irrevocable, unrestricted, unconditional, perpetual, worldwide right to make visual and/or audio recordings and still images of him/her (collectively, the "Photography") and to use the Photography and his/her name, voice, image, likeness, and biographical information in connection with CNN's production currently entitled _____ (the "Production"), and any version thereof, in materials related to the Production, and for the purpose of advertising and promoting the Production and/or the exhibitors thereof, but not as an endorsement for any product. Guest further authorizes CNN to incorporate and license others to incorporate any part or all of Guest's appearance in the Production and/or the Photography in any other production. Guest agrees that all materials created pursuant to or in connection with the Photography shall be the sole and exclusive property of CNN and that CNN shall be entitled to all rights or ownership, title, interest and all other intellectual property rights therein, and that the rights granted hereunder shall include the perpetual, worldwide right of CNN to edit, telecast, cablecast, rerun, record, publish, reproduce, use, license, print, distribute or otherwise exploit said productions (including, without limitation, the Production), in whole or in part, in any manner and in any media whether now known or hereafter devised.

2. CNN shall be under no obligation to actually use Guest's name, voice, likeness, and biographical information.

3. Guest hereby acknowledges and agrees that no payments whatsoever in connection with the Photography shall become due to Guest, and Guest hereby releases the Released Parties from any claims, obligations or liability relating thereto. Guest further agrees that he/she shall not be entitled to terminate, rescind or cancel this Release for any reason. Guest shall not be entitled to any injunctive or equitable relief whatsoever in connection with the Photography and/or any use by the Released Parties thereof.

4. Guest represents and warrants that Guest has the full right, power and authority to grant the rights set forth herein and that any statements made by Guest during Guest's appearance are true, that neither Guest's appearance nor statements will violate or infringe upon the rights of any third party, and that Guest has not been induced to enter into this Release by any representation or promise not contained herein. Guest further warrants to CNN that Guest has not accepted and will not accept any money or other compensation from any third party to mention any person, product, service, trademark or brand name, as part of Guest's appearance on the Production.

5. This Release shall be governed by the laws of the State of Georgia.
